# **PRIVACY STATEMENT – Ontario Dairy Goat Co-operative**

Thank you for visiting our Ontario Dairy Goat Co-operative (ODGC) website, hereinafter referred to as the "Site". Your privacy is important to us. To better protect your privacy, we provide this notice explaining our on-line information practices and the choices you can make about the way your information is collected and used at this Site.

## The Information We Collect About You:

You may visit our Site without telling us anything about yourself. If you contact us and choose to provide personally identifying information, we will use it for the purpose for which you submitted it to us, such as to respond to your inquiry or to send to you, information about us or the dairy goat industry. If you so choose, the types of personally identifiable information that may be collected about you at this website could include: name, address, corporate alliance, e-mail address, telephone number, fax number, results of several forms of milk testing, and information about your interest in the Ontario Dairy Goat Co-operative and the dairy goat industry. If you wish to be listed on any mailing list or receive other written materials you must first provide us with the requested personally identifiable information through our Site. We also may collect certain non-personally identifying information when you visit our Site.

### **How We Use the Information:**

ODGC does not and will not disclose, sell, rent or lease the information that you provide about yourself to third parties. We may use the information you provide about yourself to fulfill any requests, to respond to your inquiries about our co-operative, and to fulfill a request by you for written materials, except when we provide the information to any firms we retain to assist us in forwarding additional information to you, or in collecting any funds owing by you to ODGC. In addition, we will not send unsolicited messages to users of our Site who indicate that they do not wish to receive such messages. We may sometimes use non-personally identifying information that we collect to improve the design and content of our Site. We also may use this information to analyze the use of our Site. On supplying personally identifying information to ODGC, you consent to its processing and use for internal and external purposes. We may disclose personally identifiable information in response to a court order or a subpoena. We also may disclose such information in response to a law enforcement agency's request. Although we take appropriate measures to safeguard against unauthorized disclosures of information, we cannot assure you that personally identifiable information that we collect will never be disclosed in a manner that is inconsistent with this Privacy Statement.

Regardless of the precautions taken by you or by us, "perfect security" does not exist on the Internet. We cannot ensure or warrant the security of any information you transmit to us, and you transmit such information at your own risk.
